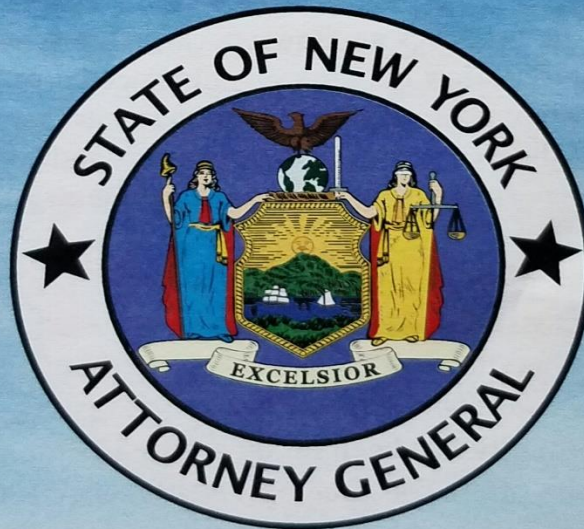

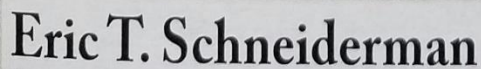


# Don't Get **BURNED**

Attorney General's Guide to Protecting  
New Yorkers From Summer Scams







- **Identify a sponsor** – Legitimate sweepstakes are usually sponsored by a company or organization with a headquarters address, a company website and contact information.
- **Have clear contest rules** – These rules let you know about eligibility to win, use of winners' names, settling disputes, etc.
- **Follow sweepstakes laws** – It is illegal for a sweepstakes to require you to make a purchase or a donation, or imply that doing so will increase your chances of winning.
- **Request a reasonable amount of information** – Entrants should expect to provide name, email or home address, and date of birth. Do not provide financial information or social security numbers on an entry form.
